

**RESOLUTION OF SPONSORSHIP FOR
A LOCAL GOVERNMENT TRANSPORTATION PROJECT FUND
AND PROJECT MATCH COMMITMENT**

Resolution No. 2021-05

A resolution declaring eligibility and intent of the Village of Angel Fire to submit an application to the New Mexico Department of Transportation (NMDOT) for Fiscal Years 2021/2022 Local Government Transportation Project Fund.

Whereas, the Village of Angel Fire, New Mexico, has the legal authority to apply for, receive and administer state funds; and,

Whereas, the Village of Angel Fire is submitting an application for the Fiscal Years 2021/2022 to NMDOT in the amount of \$ 1,361,000.00 as set forth by State legislation; and

Whereas, the San Mateo Drive, Spyglass Road Infrastructure and Roadway Improvements project named in the Local Government Transportation Project Fund application is an eligible project under the New Mexico Local Government Transportation Project Fund requirements; and,

Whereas, the Village of Angel Fire acknowledges availability of the required local match of 5% for the State of New Mexico; and,

Whereas, the Village of Angel Fire agrees to pay any costs that exceed the project amount if the application is selected for funding; and,

Whereas, the Village of Angel Fire agrees to maintain the project constructed with Local Government Transportation Project for the usable life of the project;

Now, therefore be it resolved by the Governing Body of the Village of Angel Fire, that:


1. The Village of Angel Fire authorizes Jay Mitchell, Village Manager, to submit an application for FY 21/22 New Mexico Local Government Transportation Project Fund on behalf of the Village of Angel Fire.
2. That the Village of Angel Fire assures the NMDOT that if Local Government Transportation Project Fund is awarded, sufficient funding for the local match are available, and that any costs exceed the award amount will be paid for by the Village of Angel Fire.
3. That the Village of Angel Fire assures the NMDOT that if awarded Local Government Transportation Project fund, sufficient funding for the operation and maintenance of the Local Government Transportation Project Fund project will be available for the life of the project.
4. That Jay Mitchell, Village Manager of the Village of Angel Fire is authorized to enter into a Cooperative Project Agreement with the NMDOT for the Local Government Transportation Project Fund project using these funds as set forth by state legislation on behalf of the citizens of the Village of Angel Fire. Jay Mitchell, Village Manager, is also authorized to submit additional information as may be required and act as the official representative of the Village of Angel Fire in this and subsequent related activities.
5. That the Village of Angel Fire assures that the Village of Angel Fire is willing and able to administer all activities associated with the proposed project.
