Resolution 2021-26

A Resolution Amending Water/Sewer Rates to include Fire/Domestic use meter

WHEREAS, the Fire Protection and Domestic Use combination meters are now utilized; identifying how usage shall be billed, and;

WHEREAS, the Village of Angel Fire ordinance (7-3-5H & 7-4-3-A) requires an annual rate adjustment to be effective each year on July 1 at a rate equal to the Consumer Price Index (CPI) report for the end of the previous calendar year, and;

WHEREAS, the All Urban Consumers (U.S. City average) CPI report published for December 2020 reports a 3.6% change for the 2020 calendar year for Water and Sewer and Trash Collection Services, and;

WHEREAS, the purpose of this increase is to, as a minimum, maintain the current level of service; provide better service, fulfill debt obligations and meet system growth requirements.



SCHEDULE OF WATER RATES

<u>METER SIZE</u>	<u>MINIMUM BILLING</u>	<u># OF GALLONS</u>
5/8" Meter	\$34.90	4000
3/4" Meter	\$43.55	5000
1" Meter	\$60.99	7000
1 ½" Meter	\$78.29	9000
2" Meter	\$119.80	14000
3" Meter	\$201.78	24000
4" Meter	\$336.24	40000
6" Meter	\$560.23	40000

Customer will pay \$9.00 per 1000 gallons or any fraction thereof for each additional 1000 gallons used over the monthly minimum gallons authorized for the meter size installed. **There is a \$50.00 disconnect fee for the discontinuance of water service due to non-payment and \$50.00 reconnect fee for water service restoration due to nonpayment.** Rates for customers receiving services outside the annexed Village of Angel Fire limits will be 1.5 times the rates shown. All billings are subject to applicable taxes and surcharges.

NOTE: Fire Protection/Domestic Use combination meters shall be billed as follows; Utility Billing shall bill for smaller sized water meter if there is no water usage on larger water meter for that billing cycle. Usage on the larger cycle shall be billed as a separate meter for the larger meter unless a fire has occurred and identified by AF Fire Department. Request for fire usage credit must be requested by the property owner or designee and approved by AF Fire Chief.

Sewer rates will also be billed according to water meter usage.

In addition to the base Monthly Service Charge, the customer will pay a wastewater usage rate of \$11.59 per 1000 gallons or any fraction thereof for each additional 1000 gallons. Wastewater usage is based on the consumption registered on the water meter for each meter-reading period. Rates for customers receiving services outside the annexed Village of Angel Fire limits will be 1.5 times the rates shown. All billings are subject to applicable taxes and surcharges.
