Resolution No. 2014-25

A Resolution Increasing Meter Installation Charges and Bulk Water Fees and Rescinding All Others

WHEREAS, the Village of Angel Fire ordinance (7-3-5H.1.) requires an annual rate adjustment to be effective each year on July 1 at a rate equal to the Consumer Price Index (CPI) report for the end of the previous calendar year, and;

WHEREAS, the cost of materials, supplies and labor continues to increase on an annual basis as reported in the Consumer Price Index (CPI) report for the end of each previous calendar year, and;

WHEREAS, the CPI report published for December 2013 reports a 3.8% change for the 2013 calendar year for Water and Sewerage Maintenance, and;

WHEREAS, the purpose of this increase is to, as a minimum, maintain the current level of service; provide better service, fulfill debt obligations and meet system growth requirements.

NOW THEREFORE, BE IT RESOLVED, that the Village of Angel Fire Council, on behalf of the Village of Angel Fire, New Mexico, hereby establishes the Water Meter Installation charges and Bulk Water fees for Fiscal Year 2014-15 as presented in the following attachment:

METER INSTALLATION CHARGES

1. Each customer requesting installation of metered service on their premises shall pay a charge in connection with installation of the water meter.

2. The installation charge shown for one & one-half inches (1 ½") and larger meters is for materials only and includes the water meter, pressure reducing valve and dual check backflow prevention devices. Customers will pay the cost of time and materials to install these meters. Charges will include labor, equipment time, fittings, the cost of a meter can or vault and any other related costs. The Village will determine the appropriate meter type for larger meters (turbine or compound).

BULK WATER PURCHASE CHARGES

A customer desiring to purchase water in bulk form the village must first sign a bulk water purchase agreement with the Public Utilities Department prior to receiving and hauling water. Bulk water will only be dispensed from a location authorized by the village. The customer will pay ten dollars fourteen cents (\$10.53) per one thousand (1,000) gallons or any fraction thereof plus the applicable water surcharge and taxes.
